Guidelines for Granting the Award to Outstanding Graduates of Bachelor Program

Approved by the 3rd Executive Council Meeting of 2004 Academic Year, November 26, 2004

Approved by the 5th Executive Council Meeting of 2011 Academic Year, April 25, 2012

Amendment approved by the 132nd Academic Affairs Council Meeting, June 11, 2012

Article 1. Objectives:

The Guidelines were established to recognize graduates of the Bachelor's program for outstanding academic performance and moral character.

Article 2. Applicability and criteria:

Students graduating in the academic year when the award is granted (including graduates of the current and previous semester, but excluding students already incorporated into the academic performance and ranking list of graduates for the previous academic year) if their performance meet the following requirements:

1. The average academic performance of the undergraduate student for all previous years was ranked in the 10% of the class (quota rounded to the nearest integer).

Departments may set their own selection criteria but this must be approved by the department affairs meeting and Academic Affairs Council prior to implementation.

2. The student received a grade of A- (80 in the percentage system) or higher for conduct every semester.
3. Preference will be given to students who demonstrated exceptional performance in domestic/international sports, competitions, social services, club activities or international exchanges.

Article 3. Review procedure:

Once the grades have been finalized the Office of Academic Affairs shall forward students' rankings from past years and the record of awards & punishments provided by the Office of Student Affairs to each department. The department affairs meeting then selects one student per class based on their award criteria, conditions or other performances. The candidates are then approved by the dean of the college and submitted to the University President for final approval.

Article 4. Reward:

The University President presents each winner of the award with a English and Chinese certificate at the graduation ceremony.

Article 5. The Guidelines were approved by the Academic Affairs Council and sanctioned by the University President prior to implementation. Modifications shall follow the same procedure.

第一條 目的：

為表揚學業、品德及各方面表現優秀之學士班應屆畢業生，特設置本辦法。

第二條 審定對象及標準：

凡頒獎學年度之應屆畢業生（含當學期應屆畢業生及前一學期畢業生，但前一學年度已納入應屆畢業生學業成績及名次一覽表者除外）其表現合於下列各項標準者：

一、學士班學生學業歷年總平均成績在各班級中名列前百分之十（名額採小數點進位）。

各學系得另訂篩選標準，惟須經系務會議及教務會議審議通過後公佈實施。

二、每學期操行成績A-等第(百分制八十分)以上。

三、在國內外體育、競賽、社會服務、社團活動或國際交流等方面有傑出之表現者優先考量。

第三條 審查程序：

教務處於成績定案後，將學生歷年成績排名及學務處提供之獎懲記錄送交各學系，由系務會議依其受獎標準、限制及其他表現綜合評選，審定每班各一名，並經院長同意後，陳請校長核定。

第四條 獎勵方式：

由校長於畢業典禮時頒發中英文獎狀。

第五條 本辦法經教務會議通過，陳請校長核定後實施，修正時亦同。
